Is the idea new? Is the solution driving digital change? Does it contain new ideas for implementing data governance that have not been used before?

STRATEGY

To what extent does the solution address the strategic level?

What impact does / would it have on the affected members of an organization and can / could this be made measurable?

EXPERTISE

Are the core areas of data governance applied?

USER CENTERING

Does the solution focus on the needs of the users?

COMMUNITY / REACH

Can an (open) community emerge through the implementation? Is the solution sustainable, is it aiming for national or international reach?

LEVEL OF IMPLEMENTATION

To what extent have real implementations already been achieved?

SUBMISSION CONTENT / CRITERIA

- Category of submission
- Responsible person(s) (name, e-mail, telephone number)
- Short title (50 characters)

- Abstract (max. 750 characters)
- 2-3 sentences for each evaluation criterion

REQUIREMENTS FOR SUBMITTING THE AUSTRIAN DATA GOVERNANCE AWARD

- A confirmation e-mail with an overview of the entered project data is sent in PDF format.
- Each solution can only be submitted in one of the two categories.
- The submissions are to be written in German or English.
- The expert jury only evaluates fully completed submissions. Your decision is binding.
- The judges' decision is final.
- The submitters agree to send one of the persons responsible for the project to the award ceremony on April 23, 2021.
- All submissions must be received by ADV in PDF format by 26.02.2021 at the latest to datagovernance@adv.at.

The first ten submissions in the AUSTRIAN DATA HERO category and all submissions in the category AUSTRIAN DATA HERO TALENT receive free entry to the conference. The winner of the respective category will also be invited to present at the conference.
